**WALK-IN-INTERVIEW FOR ENGAGEMENT OF PART TIME SCHOOL TEACHERS ON CONTRACTUAL BASIS IN RAILWAY SCHOOL BNR/KGP , BNR/SRC ,BNREA/Jr.Wing/KGP and BNREA/Sr. WING/KGP.**

1. It has been decided to conduct "**WALK-IN-INTERVIEW**" for filling up the following vacant posts of Teachers in **BNR/KGP , BNR/SRC , BNREA/Jr.Wing/KGP and BNREA/Sr.Wing/KGP** by engaging suitable candidates, purely on contract basis. The engagement will be on a part time basis on fixed consolidated monthly remuneration for a period not more than **200 Working Days** (Two Hundred working days) or appointment of regularly selected candidates from railway recruitment board or availability of regular railway employee whichever is earlier or as per further instructions issued by competent authority from time to time.

## 6. TERMS AND CONDITIONS:-

- i. The contractual teacher would perform all jobs related to academics including evaluation work for which no payment over and above the one for taking periods will be made.
- ii. Contractual teachers shall be entitled to one (01) day of paid leave per month. Such leave must be availed within the respective month and shall not be carried forward to any subsequent month if unutilized.
- iii. Payment of remuneration shall be made on a monthly basis, after deduction of applicable P-Tax (WB). No payment shall be made during school vacations. In the case of a broken month, remuneration shall be paid on a pro-rata basis..
- iv. The contractual teacher would not be entitled to any other facility like leave, medical, Pass/PTO, transportation, accommodation etc.
- v. The contractual teacher will have no claim or right for appointment on regular basis and will not form part of the cadre of railway teachers.
- vi. The contract shall be liable to be terminated by giving two week's notice by either side without assigning any reason. Their contract will also be terminated if their performance is found unsatisfactory during the period of their working in Railway school.
- vii. The contract shall be terminated immediately, if the teacher is mentally/physically incapacitated.
- viii. The part-time Contractual Teacher who enters into contract with the Railway will not have any claim or right for his/her continuity in service or automatic extension of the term of contract for regularization/absorption in the post.
- ix. The contractual teacher should produce a medical certificate issued by a Registered Medical Practitioner (MBBS or above) prior to entering into the contract, to ensure his/her fitness to perform the assigned duties.
- x. At the time of entering into contract, the Teacher shall produce certificates for proof of his/her good character and antecedents from two Gazetted officer of the Central/State Govt.
- xi. At the time of Interview & entering into contract, the part time teacher shall produce original certificates for proof of his/her date of birth and educational and technical qualification.
- xii. The contract teacher shall be governed in respect of matters not referred to in these terms and conditions by any order/amendments to the terms of contract issued by the Railway Administration from time to time.
- xiii. The remuneration is consolidated and Railway will not give any additional perks/facilities.
- xiv. In case of absence of duties, proportionate recovery will be made from the remuneration.
- xv. Weekly rest will be admissible as per provisions of rules. The part time teacher will have to abide by the rules of the Organization/Institution.
- xvi. The contractual teachers appointed for a period of less than a month will be paid on pro rata basis only. The pro rata payment to the teachers may be regulated as under:-

$$\frac{\text{Consolidated Pay} \times \text{Number of days worked}}{30 \text{ days}}$$

- xvii. Teachers appointed on contractual basis will not be entitled for vacation pay and during Summer/Autumn/ Winter /Puja Break, Payment shall be calculated on the Pro rata basis.
- xviii. The engagement, if done, will purely be on contract basis & the contract would be automatically terminated on the date specified for the purpose, if not, terminated earlier and the contract will not be extended under any circumstances.
- xix. The part time teacher who enters into contract with the Railways will not have any claim or right for his/her continuity or automatic extension of the terms of contract after the specified date of expiry of contract.
- xx. No TA/DA is admissible for the interview.
- xxi. If any candidate is employed, he/she will have to submit NOC from her/his employer.
- xxii. In the event of any wrong information/fake academic certificate/testimonials/mis-statement/discrepancy in the particulars being detected at any stage, the candidature/contract may be cancelled/terminated without any notice and necessary action as per extant law will be taken. Further, No correspondence in this regard will be entertained.


